What is the Hainan free trade port law?

On June 10, 2021, the 29th meeting of the Standing Committee of the 13th National People's Congress passed the Hainan Free Trade Port Law of the People's Republic of China, which determined to establish and improve the Hainan Free Trade Port customs supervision special zone system with closed-off customs operations on the entire island.

What are Hainan's new customs regulations?

Customs Supervision Regulations: New rules to streamline customs operations and enhance trade efficiency. These measures aim to establish independent customs operations, enabling seamless trade flows and strengthening Hainan's position as a global trade hub.

Will Hainan build customs supervision areas for trade liberalisation and facilitation?

Hainan will build special customs supervision areas for trade liberalisation and facilitation when independent customs operations are launched and the "free flow through the first line and control at the second line" trade policy is implemented.

When will China's Hainan free trade port open?

BEIJING, Aug. 8 -- China's Hainan Free Trade Port (FTP) is set to launch an island-wide independent customs operation on Dec. 18, 2025, underscoring the country's wider push for high-standard opening up.
